# RE: MEMORANDUM OF UNDERSTANDING FOR CYBERSECURITY MANDATE OF THE CITY OF TORONTO

# **KEY ISSUE**

Seek approval of a Memorandum of Understanding (MOU) between Toronto and Region Conservation Authority (TRCA) and the City of Toronto (the City) in response to Toronto City Council's decision to expand the mandate of the Chief Information Security Office (CISO). The MOU will establish the terms and conditions of a collaboration between the two organizations in working towards common cybersecurity goals.

# **RECOMMENDATION:**

# IT IS RECOMMENDED THAT the Memorandum of Understanding for Cybersecurity be approved.

# BACKGROUND

In May 2024, Toronto City Council adopted City Council Decision EX14.3 -Extending the Mandate of the City's Chief Information Security Officer with a goal to effectively identify and mitigate cyber risks in the City's wider cybersecurity network which includes agencies and corporations.

Under this mandate, the City requested that TRCA, in collaboration with the CISO, formulate organizational cybersecurity frameworks aligned with the following objectives:

- Provide the necessary information, access and visibility into their cyber security programs to facilitate the cybersecurity risk management partnership with the CISO;
- Operationalize CISO's recommendations to mitigate identified risks identified in the cybersecurity risk management partnership with CISO;
- Engage in consultation with the CISO on all initiatives that could potentially affect cybersecurity, including but not limited to rates of

compliance, remediation plans and strategies aimed at reducing risks and promoting compliance, and

• Engage with CISO in the event of a cybersecurity incident or data breach affecting the agency or corporation, and to work with CISO to contain, mitigate and resolve the cybersecurity incident or data breach.

The full directive outlining the relationship to TRCA is included in Attachment 1. The CISO presented this request to TRCA through its Memo of May 23, 2024. The letter is included in Attachment 2.

On November 8, 2024, a report providing a Cybersecurity Update – Response to City of Toronto Expansion of CISO Mandate was provided to TRCA's Board of Directors. The report outlined the scope of the new mandate for the Chief Information Security Office for the City, and the request being made for TRCA and other agencies and partners of the City to align programs and participate in shared cybersecurity activities.

Further, the report confirmed TRCA's support for the overall program and identified two actions for TRCA:

- 1. Negotiate a Memorandum of Understanding to guide TRCA's commitment and support for the goals of the expanded mandate of the CISO; and
- 2. Negotiate a Professional Services Agreement (PSA) to provide a framework for potential cybersecurity services to be delivered by the City of Toronto through CISO.

At Board of Directors Meeting, held on November 8, 2024, Resolution #A 164/24 was approved as follows:

IT IS RECOMMENDED THAT the Cybersecurity Update – Response to City of Toronto Expansion of CISO Mandate report be received for information.

TRCA staff have informally supported CISO activities, contributed to its initial report to City Council in November 2024, and explored opportunities to extend City services to complement TRCA's cybersecurity program. TRCA and City staff have also completed the development of the Memorandum of Understanding for the Cybersecurity Mandate.

The MOU document is included in Attachment 3.

# RATIONALE

The MOU for the CISO's Cybersecurity Mandate provides a framework for the ongoing support of the expanded mandate of the CISO. The MOU outlines:

- The term of agreement and renewal periods;
- The review period for Confirmation Program updates and any changes in services or mandate;
- Criteria for monitoring TRCA's compliance with the goals of the CISO mandate, including:
  - Scope of information sharing through the Confirmation Program to support Council reporting;
  - Consultation on cybersecurity program changes; and
  - Engagement of the CISO to provide advisory services, and for support in the event of a cybersecurity incident.

TRCA supports the mandate's goals and continues to collaborate with the CISO to meet City Council's reporting requirements. The MOU defines specific terms and expectations of the partners and is distinct from any professional services agreement for cybersecurity services, which TRCA may or may not engage in at its discretion.

# FINANCIAL DETAILS

As noted in the November 2024 report to the Board, the identified projects and immediate operational services for the Cybersecurity and Data Protection Program (015-16) will be funded through deferred contributions to reserves. ITRM continues to work with Strategic Business Planning and Performance to determine ongoing operational funding strategies.

The opportunity to outsource portions of the program to the City of Toronto

through the CISO will potentially enable TRCA to relieve a portion of this budget pressure, while also gaining access to tier-one applications and services. TRCA may also be able to leverage existing City of Toronto contracts for cybersecurity services to deploy services independently.

ITRM is continuing to evaluate the potential cost savings and operational impacts of outsourcing multiple cybersecurity services to the City.

# DETAILS OF WORK TO BE DONE

MOU must be executed between TRCA's Chair, Chief Executive Officer, and CISO.

Following the execution of the agreement, TRCA will:

- Continue to participate in meetings of the Executive Cyber Risk Management Group (ECRMG);
- Work with City staff in the CISO to complete the formal Onboarding process for the Confirmation program; and
- Continue to collaborate with City staff on cybersecurity activities within the scope of the program.

TRCA and City staff will continue to develop the Professional Services Agreement (PSA), which will provide the framework for potential cybersecurity services to be delivered by the City of Toronto through the CISO. The PSA will outline:

- The terms and conditions for outsourcing cybersecurity services to the City through the CISO, including:
  - General responsibilities and roles in service delivery;
  - Service Level Agreements for support and access to services; and
  - Protection of privacy, confidentiality and custody of information.

TRCA and City staff will continue to develop individual Statements of Work (SOW) for cybersecurity services to be provided by the City. Each SOW will detail the specific service delivery terms, operational requirements and standard procedures for each service of interest to TRCA. The PSA and SOW's will be executed following TRCA's procurement policy as a standard IT Agreement.

# Extending the Mandate of the City's Chief Information Security Officer

#### **City Council Decision**

City Council on May 22 and 23, 2024, adopted the following:

1. City Council direct the Chief Information Security Officer to establish a cyber security risk management partnership with agencies and corporations by:

a. incorporating their identified cyber risks into the City's governance and compliance risk management program;

b. conducting ongoing cyber security assessments on agencies and corporations;

c. assessing rates of compliance; and

d. developing remediation plans and strategies to reduce risk and promote compliance.

2. City Council direct the following Agencies, and as Shareholder direct the following corporations, in collaboration with the Chief Information Security Officer, to formulate organizational cyber security frameworks aligned with:

a. overarching City cyber security objectives;

b. established international cyber security standards including International Organization for Standardization ISO 27001, Statement on Standards for Attestation Engagement, the International Society of Automation / the International Electrotechnical Commission, National Institute of Standards and Technology NIST 800-171 and NIST 800-171A, and the Payment Card Industry Data Security Standard; and

c. the City's Digital Infrastructure Strategic Framework;

City of Toronto Agencies:

CreateTO; Exhibition Place; Heritage Toronto; TOLive; Toronto Atmospheric Fund; Toronto Investment Board; Toronto Parking Authority; Toronto Zoo; Yonge-Dundas Square; Toronto Transit Commission;

3. City Council direct the Boards of the Agencies, and as Shareholder direct the Boards of the Corporations set out in Part 2 above to:

a. provide the necessary information, access, and visibility into their cyber security programs to facilitate the cyber security risk management partnership with the Chief Information Security Officer;

b. operationalize the Chief Information Security Officer's recommendations to mitigate cyber risks identified in the cyber security risk management partnership; and

c. engage in consultation with the Chief Information Security Officer on all initiatives that could potentially affect cyber security, including but not limited to rates of compliance, remediation plans and strategies aimed at reducing risks and promoting compliance.

4. City Council request the following Agencies, in collaboration with the Chief Information Security Officer, to formulate organizational cyber security frameworks aligned with:

a. overarching City cyber security objectives;

b. established international cyber security standards including International Organization for Standardization, Statement on Standards for Attestation Engagement, the International

Society of Automation/the International Electrotechnical Commission, National Institute of Standards and Technology, and the Payment Card Industry Data Security Standard; and

c. the City's Digital Infrastructure Strategic Framework

City of Toronto Agencies:

Toronto and Region Conservation Authority; Toronto Pan Am Sports Centre; Toronto Police Service; Toronto Public Library; Waterfront Toronto.

5. City Council request the Agencies set out in Part 4 above to provide the necessary information, access and visibility into their cyber security programs to facilitate the cyber security risk management partnership with the Chief Information Security Officer.

6. City Council request the Agencies set out in Part 4 above to operationalize the Chief Information Security Officer's recommendations to mitigate identified risks identified in the cyber security risk management partnership.

7. City Council request the Agencies set out in Part 4 above to engage in consultation with the Chief Information Security Officer on all initiatives that could potentially affect cyber security, including but not limited to rates of compliance, remediation plans and strategies aimed at reducing risks and promoting compliance.

8. City Council forward the report (April 30, 2024) from the Chief Information Security Officer to the following Boards for their review of the issues and recommendations and consider the relevance to their respective organizations for implementation appropriate to their governance structure:

Partnered Boards (Shared Governance):

Toronto and Region Conservation Authority; Waterfront Toronto; Toronto Pan Am Sports Centre Corporation.

9. City Council direct the Agencies listed in Part 2 above and, as a Shareholder direct the corporations listed in Part 2 above and request the Agencies listed in Part 4 above to engage with the Chief Information Security Officer in the event of a cyber security incident or data breach affecting the agency or corporation, and to work with the Chief Information Security Officer to contain, mitigate and resolve the cyber security incident or data breach.

10. City Council direct the Chief Information Security Officer to engage with the Boards of the Agencies and Corporations on an as-needed basis to facilitate City Council's decision.

11. City Council direct the Chief Information Security Officer to report on specific responses and compliance rates of each Agency and Corporation on an annual basis in October of each year to the Executive Committee.

12. City Council direct the Chief Information Security Officer to report on instances of noncompliance with the above directives or requests to the Executive Committee as often as needed. 13. City Council direct that Confidential Attachment 1 to the report (April 30, 2024) from the Chief Information Security Officer remain confidential in its entirety.

Confidential Attachment 1 to the report (April 30, 2024) from the Chief Information Security Officer remains confidential in its entirety in accordance with the provisions of the City of Toronto Act, 2006, as it pertains to the security of property belonging to the City of Toronto and its agencies and corporations.

#### Summary

This report responds to a request from City Council for the Chief Information Security Officer to report on the progress of developing an implementation plan for an independent and centralized information technology risk and compliance, privacy, and cyber security function, as per item #15 of <u>2021.AU8.8</u>.

Additionally, this report recommends extending the scope of the authority of the Chief Information Security Officer to mitigate cyber security risks across all City agencies and corporations.

In 2020, City Council established the Office of the Chief Information Security Officer, an independent cyber security division based on the Auditor General's recommendation. Initially established with just five staff members, the division has since expanded significantly to meet the growing need for cyber expertise with a team of 84 cyber security experts approved 2024 complement to address emerging cyber threats.

The team, alongside four directors, is organized into distinct business sections, each with unique functions and responsibilities, and work horizontally to provide comprehensive support. The senior management team, which consists of the Chief Information Security Officer, Deputy Chief Information Security Officer, and directors from each business section, play a pivotal role in crafting and executing the City's comprehensive cyber strategy.

Within four years, the Chief Information Security Officer has formulated the organizational structure, vision, mission, and strategy of the division and has implemented a robust and effective cyber program across the City's divisions. This program is based on established international cyber security standards including International Organization for Standardization (ISO), Statement on Standards for Attestation Engagement (SSAE), the International Society of Automation / the International Electrotechnical Commission (ISA/IEC), National Institute of Standards and Technology (NIST), and the Payment Card Industry Data Security Standard (PCI DSS).

Agencies and corporations have emerged as prime targets for cyber attacks. Government and public-sector organizations are likely to continue to be among the top targets of cyber criminals seeking financial gain or competitive intelligence in the coming years.<sup>1</sup>

Over the past 24 months, Toronto Zoo, Toronto Library, and Toronto Transit Commission have each experienced debilitating cyber attacks, resulting in significant disruptions to essential services provided to residents. In February 2024, the City of Hamilton suffered from a widespread and significant cyber attack which has compromised several aspects of key technology and critical infrastructure. Most recently, on March 10, 2024, the Town of Huntsville was also hit by a cyber attack, making this the second cyber attack on a municipality within a period of only three weeks.

The impact of these disruptions highlights the importance of implementing robust and effective cyber security measures to safeguard against future threats and ensure uninterrupted delivery of services to residents.

Recent cyber incidents have highlighted the vulnerability of various agencies and corporations, particularly amidst the growing trend of threat actors targeting public organizations. In light of these incidents, there is a pressing need for agencies and corporations to leverage the capabilities offered by the Chief Information Security Officer to reinforce cyber security defences and controls and be better prepared against potential breaches.

Currently, the Chief Information Security Officer's authority with respect to agencies and corporations derives from two Council Items: <u>2019.AU4.1</u> and <u>2021.AU10.4</u>. These authorities do not cover the scope required by the Chief Information Security Officer to effectively address and mitigate cyber risks in agencies and corporations.

In response to these escalating threats, this report recommends extending the role of the Chief Information Security Officer to effectively identify and mitigate cyber risks across the City's wider cyber security network through more widespread use of modern cyber security techniques and technology across all agencies and corporations.

Securing digital assets owned and directly managed by the City is just one aspect of safeguarding the City's digital realm. The City invests significant resources in thoroughly assessing the cyber security measures of all suppliers and other organizations it engages with. Likewise, City agencies and corporations contribute significantly to the City's overall cyber posture, and would benefit from additional support, oversight, direction, and expertise from the City.

Fostering an environment of partnership and collaboration between the City and its agencies and corporations will serve to bolster the City's digital defences in an ever-evolving digital world.

**THIS MEMORANDUM OF UNDERSTANDING ("MOU")** is made as of the **##**<sup>th</sup> day of **MM**, 2024 (the **"Effective Date"**).

**BETWEEN:** 

**CITY OF TORONTO** (hereinafter, "City")

AND:

# **TORONTO AND REGION CONSERVATION AUTHORITY** (hereinafter, "TRCA")

**WHEREAS** TRCA is a conservation authority established under the *Conservation Authorities Act* ("Act") providing programs and services that further the conservation, restoration, development and management of natural resources in its watersheds;

**AND WHEREAS** the City is a single-tier municipality located wholly within the geographic area of the TRCA, and is designated as a participating municipality under the Act whose mandate is determined through City Council;

**AND WHEREAS** the City operates a cybersecurity program to protect the digital assets of the City through the Office of the Chief Information Security Officer (CISO);

**AND WHEREAS** the City Council approved City Council Decision EX14.3 - Extending the Mandate of the City's Chief Information Security Officer in May 2024, attached as Appendix A with the primary objective to establish a cyber security risk management partnership with agencies and corporations;

**AND WHEREAS** the City categorizes the TRCA as an agency in this Decision, but the parties acknowledge that TRCA operates independently of the decisions or mandate of the City or City Council;

**AND WHEREAS** the City sent a formal request on June 14, 2024 to the TRCA specifically requesting that the TRCA collaborate with the CISO to formulate organizational cyber security frameworks as follows:

- a) Provide the necessary information, access and visibility into their cyber security programs to facilitate the cyber security risk management partnership with the Chief Information Security Officer.
- b) Operationalize the Chief Information Security Officer's recommendations to mitigate identified risks identified in the cyber security risk management partnership with the Chief Information Security Officer.
- c) Engage in consultation with the Chief Information Security Officer on all initiatives that could potentially affect cyber security, including but not limited to rates of compliance, remediation plans and strategies aimed at reducing risks and promoting compliance.
- d) Engage with the Chief Information Security Officer in the event of a cyber security incident or data breach affecting the agency or corporation, and to work with the Chief Information Security Officer to contain, mitigate and resolve the cyber security incident or data breach.

**AND WHEREAS** the parties share a mutual interest to achieve the above objectives, this MOU seeks to address the request from the CISO and establish the terms and conditions of a collaboration in working towards their common cybersecurity goals.

**NOW THEREFORE** in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by the parties, the parties hereto agree as follows:

- 1. This MOU shall commence on the Effective Date and shall continue for a period of four (4) years (the "**Initial Term**"). Thereafter this MOU shall automatically renew and continue for additional periods of four (4) years each (each a "**Renewal Term**") on the same terms and conditions, unless either party provides written notice of termination to the other party at least sixty (60) days to the other party at any time or prior to the expiry of the Initial Term or Renewal Term.
- 2. This MOU shall be reviewed by the parties on an annual basis to determine if any changes or amendments are required.
- 3. The Parties agree as follows:
  - a) <u>Information Sharing:</u>
  - Upon the commencement of this MOU, the TRCA will provide the City with details about its current cybersecurity programs and activities.
  - Annually, and sooner if significant changes occur, the TRCA will update the City on any modifications to its cybersecurity programs and activities.
  - The parties agree to meet regularly throughout the Term of the MOU.
  - b) <u>Review and Assessment:</u>
  - The City will review and assess the information provided by the TRCA within the Confirmation Program Assessment
  - The City will offer recommendations to support improvements in the TRCA's cybersecurity programs and activities.
  - TRCA will review the recommendations and at its discretion, prioritize and implement recommendations based on budget resources and operational needs.
  - c) <u>Consultation:</u>
  - The TRCA, at its discretion, will consult with the City to assist with TRCA cybersecurity program planning. This may include, but is not limited to:
    - Privacy Impact Assessments
    - Threat Risk Assessments; or
    - Procurement Advisory.
  - The City shall make themselves available to provide consultation to the TRCA on an ad hoc basis to support this mutual goal.

- d) Data Breach:
- At its discretion, the TRCA will consult with the City during a cyber incident to determine appropriate steps to address the situation.
- 4. Confidential Information:
  - a) The parties shall treat as confidential information acquired or produced through the performance of this MOU, or any information provided in confidence to the other party, unless the parties agree that the information is public information, or it is required to be made available to the public in accordance with the Act.
  - b) The parties agree not to disclose any confidential information without first obtaining the written permission of the other party.
  - c) The parties agree that all confidential information will be reported in private during any governance meeting.
  - d) The parties agree that any report or update that has been provided through a governance meeting will be provided to the other party for their information.
- 5. Notwithstanding any provision in the MOU, the parties acknowledge and agree that nothing in this MOU shall be construed as amending, modifying, superseding or otherwise affecting any existing agreements between the City and the TRCA entered into prior to the Effective Date of this MOU.
- 6. The City and TRCA will continue to work together to identify opportunities for further collaboration to the benefit of both parties and ensure efficiency, transparency and accountability in the use of public sector resources.
- 7. The parties shall work together to reach agreement on and resolve any issues that arise through the implementation of this MOU, and if required any issues shall be resolved by the parties' senior executive leadership.
- 8. This MOU may be executed in counterparts and when each party has executed a counterpart, each of such counterparts shall be deemed to be an original and all of such counterparts, when taken together, shall constitute one and the same agreement. The parties may sign this MOU by means of electronic signature and deliver this MOU by electronic transmission.

Conveyance of land to address a request from Metrolinx for fee simple conveyance of Toronto and Region Conservation Authority-owned (TRCA) land located 205 Humber College Blvd, Etobicoke, ON M9W 5L7 43.729105, -79.60163 (CFN 71368).

# **RECOMMENDATION:**

IT IS RECOMMENDED THAT WHEREAS TRCA is in receipt of a request from Metrolinx for a land conveyance of TRCA-owned land located 205 Humber College Blvd, Etobicoke, ON M9W 5L7, required for the FWLRT Project, Humber River watershed;

AND WHEREAS it is in the best interest of TRCA in furthering its objectives as set out in Section 20 of the Conservation Authorities Act to cooperate with Metrolinx in this instance;

THEREFORE, LET IT BE RESOLVED THAT the parcel of TRCA-owned land, containing a total of 0.000498 hectares (0.0012305848 acres), more or less, of vacant land, and identified as Part 2 on Registered Plan M-1954, required for the FLWRT Project (PIN 073712122), in Etobicoke, be conveyed to Metrolinx;

# BACKGROUND

This request is being brought to the attention of the Executive Committee in accordance with the request for disposition of TRCA-owned property to Metrolinx for the FWLRT Project. Specifically, Metrolinx contacted TRCA Property staff with request to sell the land located at 205 Humber College Blvd, Etobicoke, ON M9W 5L7 43.729105, -79.60163. The installed Traction Power Substation (TPSS) Duct banks infrastructure for the FWLRT Project slightly extended out beyond the limits of property that was previously acquired by Metrolinx (Disposition approved on September 24, 2021 Meeting, Item 8.4 of the Agenda) from TRCA for the project, and therefore Metrolinx's contractor (Mosaic) has submitted an additional property request, as shown on the Attachment #1 & Attachment #2.

# RATIONALE

TRCA has successfully come to terms with Metrolinx on a fair market value for the minor real estate interests requested, and TRCA Planning and Technical staff have completed a review of the project to ensure the detailed design and construction are in accordance with TRCA regulatory permitting responsibilities under Section 28.1 of the Conservation Authorities Act.



# KEY ISSUE

Receipt of a request from the City of Toronto, for a permanent easement on Toronto and Region Conservation Authority (TRCA) owned lands located south of St. Clair Avenue East and Woodbine Heights Boulevard intersection, in the City of Toronto, required for Toronto Ravine Sewer Replacement Project, Don River watershed (CFN 71373).

#### **RECOMMENDATION:**

IT IS RECOMMENDED THAT WHEREAS TRCA is in receipt of a request from the City of Toronto for a permanent easement on TRCAowned lands located south of St. Clair Avenue East and Woodbine Heights Boulevard intersection, in the City of Toronto, required for Toronto Ravine Sewer Replacement Project, Don River watershed;

AND WHEREAS it is in the best interest of TRCA in furthering its objectives as set out in Section 20 of the <u>Conservation Authorities Act</u> to cooperate with City of Toronto in this instance;

THEREFORE LET IT BE RESOLVED THAT a permanent easement on a parcel of TRCA-owned land containing 0.113 hectares (0.28 acres), more or less, of vacant land, required for Toronto Ravine Sewer Replacement Project, said lands being Part of Lot 10 and Part of Road allowance between Lots 5 and 10, Concession 2 from the Bay and Part of Park Lands registered Plan 3437, designated as Part 2 on Draft

Plan prepared by Land and Property Surveys as job number 2024-04812 on March 25, 2025, in the City of Toronto, be conveyed to the City of Toronto;

THAT consideration be the nominal sum of \$2.00 and all legal, survey and other costs to be paid by the City of Toronto;

THAT the City of Toronto is to fully indemnify TRCA from any and all claims from injuries, damages or costs of any nature resulting in any way, either directly or indirectly, from this conveyance or the carrying out of construction;

THAT an archaeological investigation be completed, with any mitigation measures being carried out to the satisfaction of TRCA staff, at the expense of City of Toronto;

THAT a permit pursuant to the <u>Conservation Authorities Act</u> and Ontario Regulation 41/24 be obtained prior to the commencement of construction;

AND FURTHER THAT authorized TRCA officials be directed to take the necessary action to finalize the transaction, including obtaining any necessary approvals and the signing and execution of documents.

# BACKGROUND

The subject TRCA-owned lands were acquired from The Corporation of the Township of East York, on November 24, 1961 under the Don River Flood Plain Lands project.

Attachment 1 is a sketch illustrating the location of the subject TRCAowned lands.

Attachment 2 is an orthophoto illustrating the location of the subject TRCAowned lands.

The City of Toronto has requested a permanent easement on TRCA-owned lands required for the Toronto Ravine Sewer Replacement Project (the "Project"), located south of St. Clair Avenue East and Woodbine Heights Boulevard intersection, in the City of Toronto, required for sewer replacement, Don River watershed.

The Toronto Ravine Sewer Replacement Project involves the replacement

of 214 m of an existing 900 mm storm sewer with a new 900 mm diameter concrete storm sewer, located in the valley from St. Clair Avenue East and Woodbine Heights Boulevard to an outfall at Taylor Massey Creek, within TRCA-owned lands. The purpose of this project is to maintain aging municipal infrastructure. The scope of work on TRCA-owned lands involves open cut excavation, installation of 900 mm diameter concrete storm sewer, three maintenance holes and drop pipes, outfall reconstruction, backfilling of the excavation area, and slope stabilization at the outfall area.

# RATIONALE

The conveyance furthers the objectives of the TRCA under the <u>Conservation Authorities Act</u>. Moreover, TRCA technical planning staff have also reviewed and approve of the Project.

Furthermore, the City of Toronto and the TRCA have historically transferred lands to each other for nominal consideration. The City's request to continue this approach for the Project aligns with this practice.





#### RE: METROLINX LAND REQUIREMENTS ON TRCA PROPERTY FOR EGLINTON CROSSTOWN WEST EXTENSION (CFN 71381)

#### **KEY ISSUE**

Settlement of compensation for Toronto and Region Conservation Authority (TRCA) lands required for the construction of the Eglinton Crosstown West Extension (ECWE) project, located west of Jane Street, north of Eglinton Avenue West and east of Emmet Avenue.

#### **RECOMMENDATION:**

IT IS RECOMMENDED THAT a settlement of compensation be completed with Metrolinx with respect to an expropriation of lands municipally known as 565 Scarlett Rd; 101 Emmett Ave; 3650 Eglinton Ave W; and 3601 Eglinton Ave W, and more specifically described in Attachment 1 – Expropriated Lands Description (collectively the "Expropriated lands");

THAT the total compensation be \$200,000.00, consisting of \$95,102.00 on account of the market value for the expropriated lands pursuant to the s. 25 Offers, and \$104,898.00 as an administrative cost of settlement, inclusive of statutory interest in accordance with Section 33 of the <u>Expropriations Act</u>;

THAT TRCA provide Metrolinx with a full and complete release of all claims on expropriated lands pursuant to the <u>Expropriations Act</u>;

AND FURTHER THAT authorized TRCA officials be directed to take whatever actions may be required to give effect thereto including the obtaining of necessary approvals and the signing and execution of any documents, including an agreement on full and final release and settlement.

#### BACKGROUND

On November 23, 2022, Metrolinx registered the expropriation plan on title to the Expropriated lands and thereby expropriated all right, title, and interest in the Expropriated lands, as described in the Attachment #1. Under cover of letters dated February 16, 2023, Metrolinx served TRCA with the Section 25 offers, in accordance with the Expropriations Act, providing total compensation of \$95,102.00. The Section 25 offer provides compensation without prejudicing further claims for compensation including injurious affection and/or disturbance damages as a result of the expropriation. Negotiations continued between Metrolinx and TRCA staff, which resulted in negotiating a Full and Final Settlement Agreement, providing a total compensation of \$200,000, consisting of \$95,102.00 on account of the market value for the Expropriated lands pursuant to the Section 25 offers, and \$104,898.00 as an administrative cost of settlement, inclusive of statutory interest in accordance with section 33 of the Expropriations Act.

#### RATIONALE

Metrolinx, as a regional transit agency in Ontario, has specific powers under the <u>Expropriations Act</u>. These powers allow Metrolinx to acquire land necessary for public transit projects. Property owners whose land is expropriated are entitled to compensation, which is determined based on the market value of the property and any damages caused by the expropriation. Staff deem the abovementioned compensation fair and reasonable with respect to the market value of the expropriated interests and successfully negotiated additional compensation for administrative costs. Accordingly, the endorsement of this report will permit TRCA to finalize approval of a negotiated compensation for the Expropriated lands and further execution of a Full and final Settlement Agreement.

Staff will continue to work with Metrolinx to expedite the review of property requirements to support voluntary negotiation, as well as continue to report to the Executive Committee and the Board of Directors for property dispositions and expropriations.

#### FINANCIAL DETAILS

A Full and Final Settlement Agreement negotiated with Metrolinx provides a total compensation of \$200,000.






Temporary Easement (AT6229281)

#### RE: REQUEST FOR A RELEASE OF CONSERVATION EASEMENT AT 50 LAKE FOREST DRIVE, RICHMOND HILL, REGIONAL MUNICPALITY OF YORK (CFN 71367)

#### **KEY ISSUE**

Request from owner of the property at 50 Lake Forest Drive to free the property title from a TRCA easement and a restrictive covenant in order to pursue development of the vacant portions of the property with another single-family dwelling. Pursuant to Sections 4.2 and 4.3 of the <u>Conservation Land Act</u>, Conservation Authorities require the consent of the Minister for the release of the easement and discharge of a restrictive covenant.

#### **RECOMMENDATION:**

WHEREAS TRCA is in receipt of a request from Mr. Mauro Brancato, the owner of 50 Lake Forest Drive, to free the property and title from a TRCA easement and a restrictive covenant as part of his effort to secure planning approvals for this property;

AND WHEREAS pursuant to Sections 4.2 and 4.3 of the <u>Conservation</u> <u>Land Act</u> the release of the easement and discharge of a restrictive covenant require the consent of the Minister of Natural Resources (Minister);

AND WHEREAS staff have reviewed the request and deem that the proposed development will not result in any negative environmental impact related to TRCA's mandated areas of review;

THEREFORE IT IS RECOMMENDED THAT TRCA staff proceed with a request to the Minister for a consent for the disposition of the easement and discharge of the restrictive covenant;

AND THAT, if the Minister grants consent pursuant to Sections 4.2 and 4.3 of the <u>Conservation Land Act</u>, that TRCA receive compensation of \$459,000, in addition to the proponent paying all legal, survey, and other costs that may be required for closing;

AND FURTHER THAT, if the Minister grants consent pursuant to Sections 4.2 and 4.3 of the <u>Conservation Land Act</u>, authorized TRCA officials be directed to take the necessary action to finalize the transaction, including obtaining any necessary approvals and the signing and execution of documents.

#### BACKGROUND

Easement description and acquisition history

The easement encompassing a total area of 0.156 acres (0.063 hectares) and identified as Part of Lot 1 on Plan 65M-3824 designated as Part 8 on Registered plan 65R-28085 YR692433 (Attachment 1), is municipally known as 50 Lake Forest Drive, Richmond Hill, Regional Municipality of York. The easement also has a restrictive covenant that restricts changes to the grade and landscaping, erection of buildings, and other restrictions associated with the purposes of the conservation easement. The easement was originally acquired by TRCA from Zavala Developments Inc. pursuant to the <u>Conservation Land Act</u> for a total consideration of the sum of two dollars (\$2.00), with no municipal or provincial funding involved in the acquisition.

#### Request and review from the adjacent landowner

Mr. Mauro Brancato is the owner of the larger parent property, which includes a single-family house adjacent to the easement to TRCA-owned lands. Mr. Brancato wishes to purchase the easement from TRCA with the goal of eventually re-zoning the lot and developing it for a new single-family dwelling, contingent upon securing the necessary construction and rezoning permits. To support the request, Mr. Brancato has submitted technical reports that demonstrate the lands subject to the easement are adequately set back from the wetland and related features in compliance with the Living City Policies for development within TRCA's watershed.

TRCA's planning and technical staff have reviewed the reports commissioned to TRCA staff and concur with the findings that the proposed development will not result in any negative environmental impact related to TRCA's mandated areas of review. As a result, if the necessary Provincial approvals are obtained, TRCA Property staff may proceed with the disposition of the easement and discharge of the above-mentioned restrictive covenant on these lands. According to Sections 4.2 and 4.3 of the <u>Conservation Land Act</u>, the release of the easement and discharge of a restrictive covenant require the consent of the Minister. The owner will be responsible for obtaining all required municipal approvals.

#### Appraisal and negotiated compensation

TRCA has commissioned an appraisal for the easement that affects only a portion of the larger property. In such instances, 50% of the land's value-in-contribution is commonly identified, and thus in this instance the easement acquisition is valued at \$459,000. Accordingly, pending approval from the Minster under Section 4.3 of the Conservation Land Act, TRCA will obtain \$459,000 in compensation from the proponent, as well as any other required closing costs.

#### RATIONALE

Board of Directors approval is required for the disposition. Upon approval, TRCA will formally request for consent from the Minister in accordance with Sections 4.2 and 4.3 of the <u>Conservation Land Act</u>.


#### FINANCIAL DETAILS







#### **KEY ISSUE**

Award of Request for Tender (RFT) No. 10042488 for the East Humber River Bank Stabilization Project.

#### **RECOMMENDATION:**

WHEREAS Toronto and Region Conservation Authority (TRCA) is engaged in a project that requires general contracting services;

AND WHEREAS TRCA solicited tenders through a publicly advertised process;

THEREFORE LET IT BE RESOLVED THAT RFT No. 10042488 for the East Humber River Bank Stabilization Project be awarded to Dynex Construction Inc. at a total cost not to exceed \$293,684.00, plus applicable taxes, to be expended as authorized by Toronto and Region Conservation Authority (TRCA) staff;

THAT TRCA staff be authorized to approve additional expenditures to a maximum of \$29,368.40 (approximately 10% of the project cost), plus applicable taxes, in excess of the contract cost as a contingency allowance if deemed necessary;

THAT should TRCA staff be unable to negotiate a contract with the above-mentioned proponent, staff be authorized to enter into and conclude contract negotiations with other Proponents that submitted quotations, beginning with the next lowest bid meeting TRCA specifications;

AND FURTHER THAT authorized TRCA officials be directed to take whatever action may be required to implement the contract, including the obtaining of necessary approvals and the signing and execution

#### of any documents.

#### BACKGROUND

The East Humber River, within TRCA-owned lands, contains an asset that is currently failing and requires repair. This TRCA asset is located within Boyd Conservation Area, east of Stegman's Mill Road and Bindertwine Park. The armourstone wall, originally constructed to protect the William Granger Trail, is in poor condition, with displaced armourstones in the watercourse and significant cracking throughout the structure. Erosion scours are present both upstream and downstream of the failing wall. The downstream scour is encroaching on the existing trail, while slumping is occurring near the upstream scour.

This project consists of removal of the failing wall, installation of a replacement armourstone retaining wall, vegetated rock buttress, and stone toe trenches, and restoration works to provide continued erosion protection.

#### RATIONALE

A Request for Pre-Qualification (RFPQ) for general contractors was publicly advertised on the public procurement website www.bidsandtenders.ca on January 8, 2025 and closed on January 31, 2025. General contractors interested in pre-qualifying were advised that in order to receive a tender package they must meet the following criteria;

- A minimum total score of 65% in the following categories;
  - Company Information & Resources (weighted 20%)
  - Project Experience (weighted 40%)
  - Health & Safety (weighted 15%)
  - Qualification & Experience of Personnel (weighted 25%)

A total of thirty-seven (37) firms downloaded the documents and nineteen (19) pre-qualification submissions were received from the following Proponents:

The tenders from Arenes Construction Ltd., Lancoa Contracting Inc., M & S Architectural Concrete Ltd., QM Environmental, T.A.A. Construction Inc., and Vasq Ltd. were disqualified because they did not meet the mandatory submission requirements.

An Evaluation Committee comprised of staff from Erosion Risk Management and Construction Services reviewed the pre-qualification documents based on the criteria above. Based on the evaluation results, Request for Tender documents were issued on March 6, 2025 to the following six (6) Proponent(s):

- 560789 Ontario Limited o/a R&M Construction
- Clearway Construction Inc.
- Dynex Construction Inc.
- Hawkins Contracting Services Limited
- Lyncon Construction Inc.
- Metric Contracting Services Corporation

A mandatory meeting and site tour was held on March 13, 2025. The RFT closed on April 16, 2025.

Four (4) addendums were issued to respond to questions received.

One (1) Proponent did not submit a bid before the closing deadline.

The Procurement Opening Committee opened the Tenders on April 17, 2025 at 1:00 PM with the following results:

Staff reviewed the bid received from Dynex Construction Inc. against its own cost estimate and has determined that the bid is of reasonable value and meets the requirements as outlined in the RFT documents. Therefore, it is recommended that contract No. 10042488 be awarded to Dynex Construction Inc. at a total cost not to exceed \$293,684.00 plus 10% contingency, plus applicable taxes, it being the lowest bid meeting TRCA's specifications.



#### RE: Q1 COMMUNICATIONS, MARKETING, AND EVENTS REPORT SUMMARY (JANUARY 1 - MARCH 31, 2025)

#### **KEY ISSUE**

Information report regarding Toronto and Region Conservation Authority (TRCA) corporate media communication activities during the first quarter of 2025 (January 1 - March 31, 2025).

#### **RECOMMENDATION:**

#### THAT the Q1 Communications, Marketing and Events Report Summary for January 1 - March 31, 2025, be received.

#### BACKGROUND

The Communications, Marketing and Events (CME) business unit with involvement of program areas across TRCA's Divisions carry out corporate communications programs to provide TRCA with a unified voice that aligns consistently with strategic priorities, and monitors results to identify opportunities for improvements. Working with staff from all divisions and external program and service providers, the business units deliver communications campaigns through traditional media outlets and online social media channels. Content is typically disseminated through materials such as news releases and media advisories, direct outreach to targeted journalists, producers and editors, and responses to incoming media inquiries. Digital campaigns involve posting visual and written content on websites and distribution via social media platforms. All media activity is supported by ongoing assessment and deployment of technology tools and processes to maximize effectiveness.

#### **OVERVIEW**:

This report covers communications and marketing activities for TRCA between January 1 - March 31, 2025, achieved by the CME Team.

#### **Q1 Successes**

- The CME team successfully led the communications strategy supporting staff relocation to TRCA's new administrative office building. This included the development and rollout of key communications assets such as a series of informative emails, a professionally designed tenant handbook, detailed floor plans, and other supporting materials. CME also coordinated and delivered a successful Welcome Week event, held from February 18 to 21, which warmly welcomed staff to the new building with refreshments and snacks.
- 2. CME has transitioned paid advertising support to a specialized external media buying agency, leveraging more efficient media buys and expertise in support of paid promotional strategies for The Village at Black Creek and Conservation, Parks and Lands.
- 3. CME's media relations efforts resulted in coverage of TRCA's seasonal hiring strategy in several community publications, helping to bolster recruitment.
- 4. Proactive media relations outreach in support of Sugarbush Maple Syrup Festival also resulted in significant media coverage of the event, including broadcast remote segments.

#### Key Q1 Communications Metrics

- TRCA delivered three consolidated monthly newsletters during Q1, achieving a 50.1% average open rate (AOR) and a 4.26% click rate (CR). Both metrics significantly exceed non-profit industry benchmarks (25.17% AOR, 2.79% CR), highlighting strong audience engagement.
- 2. Google Grant Campaigns resulted in 90,437 impressions,11,457 clicks, at a value of \$67,950 US dollars in free Google ads.
- 3. CME developed and executed a comprehensive communications strategy to build awareness and drive attendance to the Source to Stream conference, resulting in 859 attendees. The campaign generated 25,320 impressions and 1,062 website clicks through a combination of organic and paid social media. Engagement for organic social media was high at 15%.
- 4. CME promoted Conservation, Parks and Lands winter activities through 33 organic social media posts that resulted in a total of 22,574 impressions and 625 engagements. Cross-country skiing at

Albion Hills Conservation Park was also promoted through paid Google ads that resulted in 359,595 impressions and 3,107 clicks to the cross-country ski page.

#### **Q1 Social Activity**

In Q1 2025, TRCA's social media strategy focused on highlighting seasonal activities, recruitment efforts, and key organizational milestones. Winter activities at TRCA parks, including cross-country skiing, were promoted to encourage visitors to embrace the outdoors during the colder months. Looking ahead to summer, the seasonal hiring campaign was launched, emphasizing roles such as lifeguards, camp counsellors, and park attendants. Early promotions for TRCA's summer camps also encouraged families to plan ahead. As the new year began, TRCA reflected on its achievements through the release of its annual report and marked a fresh start with the announcement of its new administrative office building, setting the stage for another year of meaningful conservation work.

#### TRCA's top organic posts per social media account were as follows:

- 4. On <u>X (Twitter)</u>, the top-performing post focused on the environmental impact of road salt, highlighting a BlogTO article that featured a quote from TRCA staff. External media coverage often grabs attention, particularly when it comes from a well-known local publication, and the inclusion of expert insight from a TRCA staff member added credibility and authority to the discussion. Additionally, the post resonated with followers as it addressed a common winter concern while providing actionable solutions, reinforcing TRCA's role as a trusted source for environmental education.

#### Welcome Week at 5 Shoreham

From February 18 to 20, TRCA hosted its Welcome Week for more than 300 staff at our newly opened Administrative Office Building at 5 Shoreham Drive. The event offered employees an opportunity to become familiar with their new workspace and foster a sense of connection to the site.

Orientation tours were held throughout the week, guiding staff through the office layout and highlighting key features and amenities designed to support collaboration, sustainability, and well-being.

#### Sugarbush Maple Syrup Festival Official Launch

On March 8, TRCA officially launched the Sugarbush Maple Syrup Festival and celebrated its partnership with 407 ETR, now in the second year of a three-year sponsorship commitment. Guests enjoyed a guided tour of the maple syrup trail, explored site offerings, and learning how syrup production has evolved over time.

Distinguished guests who attended and delivered remarks included:

- Darryl Gray, Director, Education and Training, TRCA;
- Christina Basil, Vice President, Communications and Government Relations, 407 ETR; and
- Anna Roberts, Member of Parliament for King–Vaughan.

Other notable guests in attendance included:

The Sugarbush Maple Syrup Festival remains a perennial favourite, drawing thousands of visitors and promoting local tourism. It also provides valuable educational opportunities and fosters strong community ties.

The festival ran from March 8 to April 6 at two TRCA locations: Bruce's Mill Conservation Park and the Kortright Centre for Conservation, attracting more than 24,000 visitors.

#### **Event Spotlight – Source to Stream**

On March 26 and 27, TRCA, in collaboration with Credit Valley Conservation (CVC) and Lake Simcoe Region Conservation Authority (LSRCA), hosted *Source to Stream*, Canada's premier stormwater and erosion and sediment control conference at Pearson Convention Centre in Brampton. The event was presented through the Sustainable Technologies Evaluation Program (STEP).

John MacKenzie, CEO of TRCA, and Quentin Hanchard, CAO of CVC, delivered opening remarks, setting a celebratory tone to launch the conference.

The event highlighted innovative projects and initiatives addressing sustainable water management, with a specific focus on urban runoff, green infrastructure, erosion and sediment control, and the restoration of natural systems. Over the course of the two-day event, attendees exchanged ideas that are shaping the future of community design and environmental protection.

From new stormwater innovations and erosion control strategies to naturebased solutions, the conference showcased practical approaches that make a measurable difference. This year's program introduced cuttingedge concepts and technologies, including Montreal's sponge parks, artificial intelligence applications, and next-generation drones, to transform how water resources are managed and protected.

The 2025 conference hosted:

- 859 attendees;
- 64 exhibitor booths;
- 8 student poster displays; and
- 37 presentations.

#### Q1 Key Learnings

- TRCA's multi-channel approach—including traditional media, digital campaigns, newsletters, and social media—continues to yield significant results. Newsletter performance far exceeded non-profit industry benchmarks with a 50.1% average open rate and a 4.26% click-through rate. Google Grant campaigns and paid media buys also proved effective, delivering more than 90,000 impressions and expanding awareness for key initiatives such as the Source to Stream conference and Conservation Parks winter activities.
- 2. TRCA events played a key role in delivering high-impact experiences for both internal and external audiences. Welcome Week successfully introduced more than 300 employees to TRCA's new Administrative Office Building, while high-profile events like the Sugarbush Maple Syrup Festival and the Source to Stream conference attracted significant participation, with more than 24,000 and 850 attendees, respectively. These events reinforce TRCA's ability to engage stakeholders, celebrate milestones, and amplify educational programming.
- 3. TRCA received more than 117 media mentions in Q1, including 17 on television or radio, reflecting the value of consistent and proactive media engagement. Strategic outreach supported seasonal hiring, festival promotion, and TRCA's response to conservation issues—from invasive species to flood preparedness. Top-performing social media posts showcased TRCA's leadership on sustainability, education, and innovation, helping to establish the organization as a trusted voice in environmental stewardship.

#### 2025 Q2 Look Ahead

Below is a list of upcoming communications activities set for Q2 2025:

1. Communication support will be provided during Q2 to promote the following:

 TRCA officially opened its new administrative office building at 5 Shoreham Drive on April 25, 2025. The event showcases the organization's commitment to sustainability, innovation, and community leadership. CME supported the event through strategic media outreach, dignitary coordination, onsite logistics, and internal communications.

- As the spring and summer seasons unfold, TRCA will promote the reopening of parks and natural spaces throughout its jurisdiction. CME will provide digital marketing, branding, and media relations to raise awareness and drive attendance.

#### **KEY ISSUE**

Receipt of Toronto and Region Conservation Authority's (TRCA) unaudited expenditures as of the end of the first quarter, March 31<sup>st</sup>, 2025, for informational purposes.

#### **RECOMMENDATION:**

#### IT IS RECOMMENDED THAT the 2025 financial report for the threemonth period ending March 31, 2025, be received for information.

#### BACKGROUND

As part of TRCA's financial governance procedures, staff are presenting the 2025 Three Month Financial Report, covering the period from January 1, 2025, through to March 31, 2025. This report provides information on the expenditure rate for the first three months of 2025.

#### RATIONALE

TRCA prioritizes transparency and accountability in spending, revenue recognition, and performance evaluation against approved budgets, both at the organizational level and within individual project and programs. This is further supported by TRCA's core values which prioritize accountability of staff to be increasingly responsible for their actions, behaviours, and outcomes. TRCA recognizes that all projects and programs have cost implications and that all expenditures support practical and affordable service delivery. Transparency throughout the budget management process is achieved in part through the analysis and reporting on year-to-date revenues/expenses as compared to the current fiscal year budget. In addition, TRCA regularly collaborates with municipal and government agency partners, sharing budget expenditure and variance information throughout the year and during budget planning for the upcoming fiscal period. In order to improve the accuracy in reporting anticipated issues in

expenditures, TRCA established a seasonal forecasting baseline using historical data from the past three years to estimate the seasonal variances within each program area.

#### **FINANCIAL DETAILS**

Capital and operating reports by Service Area and underlying Program Areas are provided in Attachments 1 and 2, respectively. The attachments provide a summary analysis of expenditures to date and the variance explanations by Program Area which have a variance threshold of +/- 10% and \$500,000 from anticipated quarterly spend rates. This threshold ensures attention is directed to significant or unexpected deviations while maintaining operational efficiency. Variances falling within these thresholds are considered to be within the expected range.

A summary of the three-month operating and capital expenditures is shown in Table 1 below.

As TRCA's financial governance procedures and systems continue to evolve over time, internal processes for in-year vendor billing, customer invoices and recognition of deferred revenue and internal recoveries will become a greater area of focus for the organization. TRCA will continue to monitor expenditure trends closely and adjust forecasting as needed to ensure strong fiscal management across all service areas.
