RE: **UPDATE ON DELEGATED MAJOR PERMITS – JULY AND AUGUST 2022**

KEY ISSUE

Toronto and Region Conservation Authority (TRCA) staff are required to report back on any major permits issued through the approved delegated process during the months of July and August 2022.

RECOMMENDATION:

THAT the staff report regarding the staff issuance of major delegated permits during the period of July and August 2022, be received.

BACKGROUND

At Board of Directors Meeting #8/20, held on November 20, 2020, Resolution #A183/20 was approved as follows:

THAT the approval of all major development and infrastructure permits within TRCA's regulatory jurisdiction for the months of December 2021 and July, August and December 2022 be delegated to the Director, Development and Engineering Services or their designate;

THAT TRCA staff provide a report to the Executive Committee at the January and September 2022 and January 2023 meetings to summarize permits that were approved under this delegation of authority;

RATIONALE

During the months of July and August 2022, staff issued no major development permits and one major infrastructure permit within TRCA's regulatory jurisdiction, as follows:

1. A permit was issued for the installation of two watermain along Old Whitevale Road, 650 metres east of Whites Road, and to construct the new Alexander Knox Roadway (realigned Whitevale Road) from approximately 1 kilometer west of Whites Road to approximately 700 metres east of Whites Road in the City of Pickering. The proposal includes two (2) new watercourse crossings as a result of the new road construction and will also include the construction of a watermain. These works are part of the servicing for the new Seaton community in the City of Pickering and were previously reviewed through the Central Pickering Development Plan Class Environmental Assessment (EA) for Regional Services (June 2014).

As required, the Clerk provided a copy of the attached permit report to Board of Directors members in the representing the affected area for a review period of one week.
