Toronto	Hybrid (year limit as of May)	There are no specific parameters, just that some or all members can participate remotely. These changes to the Procedures By-Law are time limited, and expire one year after the termination of the COVID-19 emergency (the Mayor terminated the emergency in May). Staff will be reporting back to Council early next year with recommendations on the future of electronic participation, but it expect it to continue possibly with some limitations/conditions.
Uxbridge	Hybrid	No limits, updating procedure by-law to reflect hybrid meeting practices moving forward.
King	Virtual	Completely virtual but looking to move to hybrid in the future. However, virtual is working well for their members.
Mono	Virtual	No limits, planned to transition to hybrid, however; increase in covid numbers led to decision for continuation of completely virtual meetings.
